

Immigration to Canada. Beware of fake offices by Israa Hussein – Canada, Al Jazeera, 24/8/2019



Lawyer Corrigan offers advice to immigrants (Al Jazeera Net)

The Canadian government has revealed from time to time that many immigration files to Canada have been submitted by fake offices or committing fraud on clients, whether these offices are in Canada or abroad. Those offices are suspended and their owners punished if they are inside Canada, but outside the government there is no power to do so.

The fate of immigration applicants is also to enforce the law negatively after, how can those who want to immigrate to Canada take the right path in immigration steps, and how can they know if those offices are not defrauding him?

The ideal lawyer?

Edward C. Corrigan- He is one of Canada's leading immigration and asylum lawyers.

He tells Al Jazeera Net that those wishing to immigrate to Canada pay a lot of money to some of these offices inside or outside the country and is not sure whether they are real

or fake or have licenses from the government, and clients may lose large amounts as well as the loss of effort, time and long waiting times.

Corrigan adds that an immigration applicant can shorten that by processing the immigration file through a Canadian lawyer. He justifies his advice that if the applicant is not represented properly circumvented, he or she can complain through a Canadian Law Society.

Corrigan explained that the Canadian Lawyer is aware of the country's law, and that lawyers specialized in this field are known and have the right to work on an immigration files by the government.

The lawyer must treat a confidential to all information of the client.

The lawyer, after the evaluation session between him and the client and through experience, determines whether this file complies with the requirements of immigration, or if there are some points that must be worked on or developed.

One of the reasons for the Canadian Lawyer preference - according to Corrigan - is that the client can make sure if there is any complaint against the lawyer or if they are suspended from work, by searching for their name and license number registered with a Canadian Law Society. (e.g. Law Society of Ontario)

300 thousand immigrants annually

Corrigan says that Canada annually accepts about 300,000 immigrants, around sixty thousand refugees and the rest are migrants, and the options for migration to Canada are therefore numerous, including investment, express entry, skilled worker, provincial nominee and other programs.

When a lawyer receives information from the client, he or she can determine according to which program the applicant can apply.

How to find what you are?

Corrigan explains to Al Jazeera Net that our world today is small with the presence of the internet, anyone who wants to immigrate and is looking for a qualified lawyer should go to a Canadian Law Society website and look for specialized lawyers.

And who wishing to emigrate he/she can find through this website, full information

about any lawyer and his / her experience and information.

He also cautioned that the information in the immigration files must be accurate, because if the Canadian Government sees that they are incorrect, this is reflected negatively on the file of the applicant and result in rejecting the application.
